#### About Joel Feldman

Mr. Feldman is a shareholder of Anapol Schwartz, a personal injury law firm in Philadelphia, Pennsylvania. He has a master's degree in counseling and uses his counseling skills to supplement his legal experience. For more than 30 years, he has represented those who have been injured, or the families of those whose loved ones have been killed in a variety of cases, with a special emphasis on distracted driving truck and car crashes. He also represents consumers whose brokers have mismanaged their accounts, often losing their life's savings.



Following the death of his daughter, Casey, by a distracted driver in 2009, Mr. Feldman has become one of the leading advocates for safe, non-distracted

driving in the United States. He has created public service announcements used in distracted driving programs across the country. Mr. Feldman worked with Children's Hospital of Philadelphia to develop a scientifically-based and effective distracted driving presentation. He trains professionals to give effective distracted driving presentations in their communities. More than 150,000 teens and adults have seen the presentation in more than 40 states. He coordinates the efforts of more than 700 lawyers, health care professionals, safety advocates and driver's education professionals in giving presentations. He developed End Distracted Driving (EndDD.org), one of the leading distracted driving websites. He is a member of the USDOT's Driver Distraction Leadership Committee.

He is a member of the American Association for Justice's (AAJ) Trial Lawyers Care Committee, which encourages trial lawyers to work in their communities with local non-profit organizations. Through this committee, articles and presentations he encourages lawyers to be more involved in their communities and to be more caring and compassionate in the representation of their clients.

For his efforts to raise awareness of the dangers of distracted driving, Mr. Feldman has received a number of awards including the American Association for Justice (AAJ) 2013 Pro Bono Award, The 2013 Magee Rehabilitation Hospital Humanitarian of the Year Award, the 2013 Massachusetts Academy of Trial Attorneys (MATA) Courageous Advocacy Award, the 2012 Colorado Trial Lawyers Association (CTLA) Consumer Safety Advocate Award, the 2012 Kentucky Justice Association and Kentucky Family Safety Foundation Consumer Safety Award, the 2012 60for Safety Community Outreach Award and the 2011 Pennsylvania Association for Justice (PAJ) Community Service Award. Mr Feldman's distracted driving initiatives were featured in a 2013 article by the Civil Justice Foundation Project Spotlight: "Attorneys who stand up and make a difference for consumers."

Mr. Feldman is committed to raising awareness of the dangers of distracted driving. He regularly speaks with teens, college students, health professionals, safety professionals and businesses about distracted driving, telling his personal story of loss and using his counseling skills to effectively promote attitude and behavior change. He has spoken with more than 25,000 teens and adults about distracted driving, and regularly produces PSAs, including one for the U.S. Department of Transportation (USDOT), which is used in safety talks all over the U.S. and in Canada. He frequently writes articles for organizations about distracted driving, including individual state trial lawyer organizations and USDOT. He has given more than 150 presentations about distracted driving.



#### About Bobby Lee Cook

Over six decades ago, Bobby Lee Cook and the late A. Cecil Palmour opened a law firm together in the small town of Summerville, GA, which is tucked in the northwest corner of the state. Sixty-six years later, Bobby Lee is still practicing at the same firm – now Cook & Connelly – and is showing no signs of slowing down.

Bobby Lee Cook has tried thousands of cases, including more than 300 murder trials, in more than 40 states and several countries. He's represented virtually every client imaginable over his more than half-century of



practicing law, ranging from moonshiners and bootleggers to white collar elites including members of the Rockefeller and Carnegie families. He is unanimously regarded as one of the South's best defense attorneys.

After graduating from Vanderbilt University Law School and returning to Summerville, Bobby Lee served one term in the State House of Representatives, one term in the State Senate and on the Bench for four years as a State Court Judge. Since then, his time has been solely devoted to private practice and the representation of individuals in criminal defense and plaintiffs' personal injury, wrongful death and medical malpractice cases.

Bobby Lee has received the Georgia Trial Lawyers Association's Guardian of Justice Award, has been inducted into the American Trial Lawyers Hall of Fame and this summer will be recognized by the *Daily Report* as a recipient of the inaugural Lifetime Achievement Award.

The television show *Matlock* was reportedly based on Cook's practice, and his defense of Savannah socialite Jim Williams helped bring to life John Berendt's true-crime classic *Midnight in the Garden of Good and Evil*.
